President Crowley: Applicant for facility manager is Lee Griffin.

- Tim is going to Wells, YCCC today to discuss Water Treatment, and farewell to YC President Finkelstein. Will speak with Patrick Wiley about Water Treatment program.
- Budget is close to being done in Augusta.
- Mrs. Smith will be in town tomorrow. She will be invited to reception on Thursday. Tim will meet with her at end of the week and will talk about dining commons.
- Emily Knowles is leaving--English position will be posted soon. Will post ACS position by next week.
- Water Treatment program grant with the National Science Foundation has surfaced again. We will try again. University of Maine and Bangor High School are working on it. If successful, it would establish a program at UTC or Bangor High.
- Spoke to President Knapp about Water Treatment program in Wells and he approves what we are doing.

- Working on IT policies. Cabinet will review them.

Beth—Payroll week, processing new contracts, work-study contracts. Beth will be out this afternoon.

Dottie—Bring College to ME grant was submitted on Friday and hope to hear this week.
