

Cabinet Meeting 3/22/2019

President Crowley—Materials are being handed out at the President Council meetings (**from every campus to every campus**) and President Crowley will share it with us. Enrollment information from all campuses was handed out along with non-credit activity including Maine Quality Centers. System may try to combine those numbers so that it shows the growth in the total activity mostly non-credit. Strategic planning final docs from campuses were distributed.

- We submitted Bring College to ME Grant application –Community Paramedicine Downeast. Similar to what NM is doing with the Nursing program in Washington County. Probably won't be funded because it's all online and we would need permission from the accrediting group. Nursing from NM won't continue in Washington County as of this academic year, but WCCC is now asking for a similarly-delivered Paramedic Program for them. **This looks positive so we will modify the application by April 3.** It's possible we could deliver the Paramedine program to Bangor as well, but not sure yet.
- June Community College System Conference in Bangor—they are looking for proposals to present. Johna Lovely might want to present at this conference regarding ATD. President Crowley will attend and others are invited to go.
- President Daigler will be here on April 25. Breakfast with Foundation and General Advisory, then tour campus, lunch with employees. Wants to talk with people/answer questions. Same day as EMBARK and Water Treatment. Daigler will attend graduation. Dan Belyea is being utilized at the legislature to connect and represent System. We need to separate NMCC from the PLC and Dan Belyea can take over.
- One more conversation is scheduled with President Rice regarding the time-of-graduation faux pas.
- Student navigator discussion will lead to funding. System will put up money to keep it going and will no longer be supported by private grant money.
- LPN program begins next Thursday and **President Crowley would like publicity on this on the first day of class.** Everything is in place...14 students are confirmed.
- Each manager of the campuses make a report about what has been accomplished. President Daigler is extending the length of the Trustee Board meetings to make sure to have meaningful discussion during the public portion of the meetings.

Barry—Courtney has gone through the phone system and some people don't have a voicemail welcome message. **Barry will share the list of those folks so that recordings will be completed and the dial-by-name directory will work.**

Mike—Union representative was on campus yesterday without advising President Crowley or supervisor in the area, and did interviews with maintenance staff. **President Crowley will talk to Tammy about the correct procedures.**

Dottie mentioned faculty management committee hasn't met yet this year.

Edward--April 8 NM is invited to have a representative at the Plumbing Board in Augusta. **Ed will go to Eggs and Issues at Sorpreso to listen to presentation by Paul Towle, AP, regarding workforce development to make sure we are represented fairly.**

Bill—Workforce Investment Board—we don't seem to be on the list of information being distributed. Who at this college is being contacted? We need to sign agreements with all three providers in Maine and there is a financial commitment from the institution. **President Crowley, Leah and Bill will follow up.**
