- St. Joseph's College—Articulating a 3+1 agreement which will hopefully be complete by the end of the semester. Students can get Associates in nursing then continue taking courses here and transfer to St. Joseph's for one year to get bachelor's degree.
- Working on agreement with Maine Maritime Academy working on 2+2 agreement. Not sure what we
 have in place currently.

- D2L—Migration has been successful. JR is point person. Tammy Nelson will message students about this change. Training sessions will be open to faculty.
- Retention rate of students seeking help in Academic Success Center is up and technology in the Center is working well.
