New Business

- I. Moving courses online
 - a. We currently have about 50% of courses online
 - b. Most campuses are in the 80% range
 - c. We have been asked to move more courses online
- II. Wellness Center
 - a. Plan is based on state's guidelines for fitness centers and gyms
 - b. Have set a capacity for the fitness center and gym
 - c. Phased re-opening Monday, August 17th
 - i. Students and staff
 - ii. No public
 - iii. Face covering required
 - iv. No showers/changing in locker rooms, only restrooms can be used
 - v. Will take temperature upon entering
 - vi. Must check in with ID card
 - d. Gym
 - i. Have setup some cardio machines (spin bikes, rowing machine) that don't require electricity in the gym
 - 1. This helps reduce the number of people in the fitness center
 - ii. Walking track will go in one direction only
 - 1. If passing someone, use social distancing
 - e. Clean equipment before and after use
 - f. Will be having outdoor spin class
 - g. Staff will be masked and gloved up
 - h. Staff will receive special training related to COVID procedures
- III. Akeley Student Center
 - a. Important to have someone stationed at the desk
 - b. Double check that people have completed the checklist on the app
 - c. Will direct traffic if people come in and they aren't sure where to go
- IV. Trade and Tech

- a. President Crowley, Pam, and others went through lab areas with Tony Jones from MEMIC on July 22
- b. Reduce enrollment in Plumbing & Heating and Diesel
- V. Mechanized Logging Operations Program
 - a. Student called in sick temperature and sore throat
 - i. Was in class yesterday in a piece of equipment for most of the day
 - ii. We've asked him to speak with his physician
 - iii. Must be symptom free for 72 hours before returning
 - b. Our response was to send all students home
 - i. Class not meeting today or tomorrow
- VI. Round table
